WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor, Materials, and Equipment for the "Repair of Storage Building at PPD Compound", Port of Zamboanga, Zamboanga City with An ABC of Php996,200.00 on May 29, 2023 to June 5, 2023 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;
