



**BAC RESOLUTION DECLARING LOWEST AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

**ONE (1) LOT SUPPLY OF LABOR AND MATERIALS FOR THE ON-SITE GENERAL CLEANING OF AIR CONDITIONING UNITS OF PPA, PMO ZAMBOANGA FROM APRIL 1 TO DECEMBER 31, 2023, WITH AN ABC OF PHP244,350.00**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor and Materials for the on-site general cleaning of Air Conditioning Units of PPA, PMO Zamboanga from April 1 to December 31, 2023 with an ABC of Php244,350.00, on February 13 to 20, 2023, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards.

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) King Ref & Aircon Refrigeration Enterprises, 2.) Frost King Airconditioning and Refrigeration and 3.) Marzky Refcon Service Center. Out of the three (3) only two (2) submitted.

WHEREAS, the BAC opened the sealed price quotation of supplier on February 20, 2023, at 2:00PM. The results were as follows:



To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.




