ONE (1) LOT SUPPLY OF PETROLEUM, OIL, LUBRICANT AND OTHER ACCESSORIES TO PPA, PMO ZAMBOANGA OFFICE MOTOR VEHICLES, GENERATORS SETS, RIGID BUOYANT BOAT FROM JULY 1 TO DECEMBER 31, 2023, WITH AN ABC OF PHP974,600.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Petroleum, Oil, Lubricant and other accessories to PPA, PMO Zamboanga Office Motor Vehicles, Generators Sets, Rigid Buoyant Boat from July 1 to December 31, 2023, with an ABC of Php974,600.00, on April 17, 2023 to April 24, 2023 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;
