QUOTATION AND RECOMMENDING APPROVAL**

ONE (1) LOT SUPPLY OF LABOR AND MATERIALS FOR THE PROVISION OF VARIOUS SERVICES SUCH AS PHOTOCOPY, BLUE AND WHITE PRINTING, BINDING, RISO/DUPLO PRINTING, CAD PLOTTING, TARPAULIN PRINTING, NOTEPAD AND CALLING CARD PRINTING, PRINTING OF SIGNAGE ON ACRYLIC BOARD AND FABRICATION OF TEMPORARY VEHICLE PLATE FOR THE OFFICIAL SERVICE VEHICLE OF PPA, PMO ZAMBOANGA FROM JULY 1 TO DECEMBER 31, 2023, WITH AN ABC OF PHP510,500.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor and Materials for the Provision of Various Services such as Photocopy, Blue and White Printing, Binding, Riso/Duplo Printing, CAD Plotting, Tarpaulin Printing, Notepad and Calling Card Printing, Printing of Signage on Acrylic Board and Fabrication of Temporary Vehicle Plate for the Official Service Vehicle of PPA, PMO Zamboanga from July 1 to December 31, 2023, with an ABC of Php510,500.00, on April 17, 2023 to April 24, 2023 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;



To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


