QUOTATION AND RECOMMENDING APPROVAL**

**ONE (1) LOT SUPPLY AND DELIVERY OF PURIFIED DRINKING WATER IN
ROUND CONTAINERS AND BOTTLED WATER FOR PPA, PMO ZAMBOANGA
FROM JULY 1 TO DECEMBER 31, 2023, WITH AN ABC OF PHP245,800.00**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot supply and Delivery of Purified Drinking Water in Round Containers and Bottled Water for PPA, PMO Zamboanga from July 1 to December 31, 2023, with an ABC of Php245,800.00, on April 17, 2023, to April 24, 2023 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC opened the sealed price quotation of supplier on April 24, 2023, at 10:00AM. The results were as follows:

WHEREAS, the result of the Documentary Requirements Validation Report dated April 27, 2023, conducted by the BAC-TWG the submitted documents of Oceanah Water Refilling Station is Non-Responsive. Pursuant to Sec. 34.6 Rule X of the 2016 Revised Implementing Rules and Regulations of RA 9184 which states, "XXX the BAC shall initiate and complete the same post-qualification process on the bidder with the second lowest calculated bid/highest rated bid. If the second bidder passes the post-qualification, and provided that the request for reconsideration of the first bidder has been denied, the second bidder shall be post-qualified as the bidder with the LCRB or HRRB."



NOW THEREFORE, We, the Members of the PMO Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:



To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


