

## BAC RESOLUTION DECLARING SINGLE LOWEST AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

ONE (1) LOT SUPPLY OF LABOR ONLY FOR THE MINOR REPAIR AND MAINTENANCE SERVICE OF OFFICE MOTOR VEHICLES OF PPA, PMO ZAMBOANGA FROM APRIL 1 TO DECEMBER 31, 2023 WITH AN ABC OF PHP454,500.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor only for the minor repair and maintenance service of office motor vehicles of PPA, PMO Zamboanga from April 1 to December 31, 2023 with an ABC of Php454,500.00, on February 13 to 20, 2023, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards.

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) AM Car Aircon Services, 2.) Mhond Automotive Repair Services and 3.) ZC Tyre Pro Canter Inc. Out of the three (3) only one (1) submitted.

WHEREAS, the BAC opened the sealed price quotation of supplier on February 20, 2023, at 2:00PM. The results were as follows:
