ONE (1) LOT SUPPLY OF LABOR, MATERIALS AND EQUIPMENT FOR THE REPAIR OF TOILET AT HALFWAY HOUSE COMPOUND, PORT OF ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC OF PHP582,683.22

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor, Materials and Equipment for the Repair of Toilet at Halfway House Compound, Port Of Zamboanga, Zamboanga City with an ABC of Php582,683.22 on June 19, 2023 to June 26, 2023 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;


