



BAC RESOLUTION DECLARING FAILURE OF BIDDING AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. SVP-20-2023

1ST RE-ADVERTISEMENT: ONE (1) LOT SUPPLY OF LABOR, MATERIALS AND EQUIPMENT FOR THE IMPROVEMENT OF INTERIOR WALL AT THE OFFICE OF THE PORT MANAGER, PORT OF ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC OF PHP403,800.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor, Materials and Equipment for the Improvement of Interior Wall at the Office of the Port Manager, Port of Zamboanga, Zamboanga City with an ABC of Php403,800.00, on June 26 to July 3, 2023, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotations (RFQ) to four suppliers, namely: 1.) AJ Construction and Trading, 2.) Shiehan Construction and Enterprises, 3.) K-Lanz Construction and Supplies;

WHEREAS, in the opening of sealed price quotation on July 3, 2023, 10:00 AM no envelope was received from the invited suppliers;

NOW THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


To declare the procurement of **ONE (1) LOT SUPPLY OF LABOR, MATERIALS AND EQUIPMENT FOR THE IMPROVEMENT OF INTERIOR WALL AT THE OFFICE OF THE PORT MANAGER, PORT OF ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC OF PHP403,800.00** as a failure of bidding since there were no interested supplier.

To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.
