



BAC RESOLUTION DECLARING FAILURE OF BIDDING AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. SVP - 22-2023

ONE (1) LOT SUPPLY AND DELIVERY OF RESPONSE AND CONTAINMENT MATERIALS AND EMERGENCY SHOWER EYEWASH STATION WITH AN ABC OF PHP252,000.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply and Delivery of Response and Containment Materials and Emergency Shower Eyewash Station with an ABC of PHP252,000.00, on July 19 to July 25, 2023, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotations (RFQ) to three (3) suppliers, namely: 1.) Victorious General Merchandise and Services, 2.) Asiatic Trading Corp., 3.) Electron Comtronics and Service Center;

WHEREAS, in the opening of sealed price quotation on July 25, 2023, 2:00 PM no envelope was received from the invited suppliers;

NOW THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

To declare the procurement of **ONE (1) LOT SUPPLY AND DELIVERY OF RESPONSE AND CONTAINMENT MATERIALS AND EMERGENCY SHOWER EYEWASH STATION WITH AN ABC OF PHP252,000.00** as a failure of bidding since there were no interested supplier.

To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


