



BAC RESOLUTION DECLARING FAILURE OF BIDDING AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. SVP-21-2023

ONE (1) LOT SUPPLY OF MANPOWER, TOOLS/EQUIPMENT, AND PROVISION OF BASIC SPECIALIZED PPE FOR THE COLLECTION, TRANSPORTATION AND TREATMENT OF HAZARDOUS WASTE WITH AN ABC OF PHP299,478.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Manpower, Tools/Equipment, and Provision of Basic Specialized PPE for the Collection, Transportation and Treatment of Hazardous Waste with an ABC of PHP299,478.00, on July 19 to July 25, 2023, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotations (RFQ) to three (3) suppliers, namely: 1.) Vertex Maritime International Trading Inc., 2.) Far East Fuel Corp., 3.) ARC Merchandising;

WHEREAS, in the opening of sealed price quotation on July 25, 2023, 2:00 PM only one (1) supplier submitted their price quotation-Far East Fuel Corp. However, the document submitted were declared FAILED due to failure on our part to include the detailed estimates of cost breakdown in the PhilGEPS postings;

NOW THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

To declare the procurement of **ONE (1) LOT SUPPLY OF MANPOWER, TOOLS/EQUIPMENT, AND PROVISION OF BASIC SPECIALIZED PPE FOR THE COLLECTION, TRANSPORTATION AND TREATMENT OF HAZARDOUS WASTE WITH AN ABC OF PHP299,478.00** as a failure of bidding due to incomplete submission of bidding documents.

To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


