RECOMMENDING APPROVAL**

**ONE (1) LOT SUPPLY OF ELECTRICAL SUPPLIES FOR ADMINISTRATIVE
DIVISION-POWERHOUSE WITH AN ABC OF PHP105,590.00**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Electrical Supplies for Administrative Division-Powerhouse with an ABC of Php105,590.00 on June 19, 2023 to June 26, 2023 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to three (3) suppliers, namely: 1.) Expo Home Depot Corp., 2.) Nationwide Sales Corp.; 3.) Electron Comtronics and Services, and that all suppliers submitted their price quotation;

WHEREAS, the BAC opened the sealed price quotation of supplier on July 25, 2023, at 2:00PM. The results were as follows:
