**BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND
RECOMMENDING APPROVAL**

BAC RESOLUTION NO. SVP- 12 - 2018

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with Section 53.9-Small Value Procurement of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 posted the Request for Quotation (RFQ) for the "One (1) Lot – Supply, Delivery, and Installation of One (1) Unit Air Conditioner, Floor Mounted, 3-Tonner with Inverter" of PPA, PMO-Zamboanga with an Approved Budget for the Contract (ABC) of Php 120,000.00 from May 30-June 13, 2018, in the PPA Website, PhilGEPS Website, and PPA-PMO Bulletin Boards;

WHEREAS, RFQs were sent to three (3) suppliers, namely: 1) Emcor, Incorporated; 2) Z.C. LM Enterprises; and 3) Solidmark, Incorporated;

WHEREAS, out of the three (3), only Emcor, Incorporated, submitted its Price Quotation Envelopes before the deadline;

WHEREAS, the BAC opened the envelopes of Emcor, Incorporated on June 13, 2018 at 10:00 AM containing the Technical and Financial Requirements;

WHEREAS, the submitted technical documents were checked and found compliant, and rated as "Passed". The financial documents were checked and evaluated, and the Price Quotation was announced by the Chairperson as Php107,695.00 less than the ABC of Php120,000.00;

WHEREAS, upon validation on the documentary requirements of Emcor, Incorporated, the BAC found the Technical and Financial documents as responsive;

WHEREAS, the BAC declared Emcor, Incorporated as the Single Calculated and Responsive Quotation for the One (1) Lot – Supply, Delivery, and Installation of One (1) Unit Air Conditioner, Floor Mounted, 3-Tonner with Inverter;

NOW, THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby, RESOLVE, as it is hereby RESOLVED:

- 1) To endorse Emcor, Incorporated as the supplier with the Single Calculated and Responsive Quotation for the One (1) Lot – Supply, Delivery, and Installation of One (1) Unit Air Conditioner, Floor Mounted, 3-Tonner with Inverter in the amount of Php 107,695.00; and
- 2) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.


