



**BAC RESOLUTION DECLARING LOWEST AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

**ONE (1) LOT SUPPLY OF MANPOWER, TOOLS/EQUIPMENT, AND PROVISION OF BASIC & SPECIALIZED PPE FOR THE COLLECTION, TRANSPORTATION AND TREATMENT OF HAZARDOUS WASTE WITH AN ABC OF PHP299,478.00**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the ONE (1) LOT SUPPLY OF MANPOWER, TOOLS/EQUIPMENT, AND PROVISION OF BASIC & SPECIALIZED PPE FOR THE COLLECTION, TRANSPORTATION AND TREATMENT OF HAZARDOUS WASTE WITH AN ABC OF PHP299,478.00 on August 3 to 9, 2023, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to three (3) suppliers, namely: 1.) ARC Company, 2.) Far East Fuel Corporation; 3.) Vertex Maritime International Trading Inc., out of the three (3) only one (1) submitted their price quotation;

WHEREAS, the BAC opened the sealed price quotation of supplier on August 9, 2023, at 2:00PM. The results were as follows:
