**BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

**BAC RESOLUTION NO. SVP-16-2018**

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement re-posted the Request for Quotation (RFQ) for the "One (1) Lot-Supply of Labor and Materials for the Minor Repair and Maintenance Services of Motor Vehicles of PPA, PMO-Zamboanga for CY2018" with an Approved Budget for the Contract (ABC) of Php 100,000.00 from June 13-25, 2018, in the PPA Website, PhilGEPS Website, and PPA-PMO Bulletin Boards;

WHEREAS, RFQs were sent to three (3) suppliers, namely: 1) Zamboanga Motors, Incorporated; 2) E.A.E. Gonzales Auto Repair Shop; and 3) La Hermosa Pit Stop Shop & General Merchandise, Incorporated;

WHEREAS, out of the three (3) suppliers, only La Hermosa Pit Stop Shop and General Merchandise, Incorporated, submitted its Price Quotation Envelopes before the deadline;

WHEREAS, the BAC opened the envelopes of, La Hermosa Pit Stop Shop and General Merchandise, Incorporated on June 25, 2018 at 10:00 AM containing the Technical and Financial Requirements;

WHEREAS, the submitted technical documents were checked and found compliant, and rated as "Passed". The financial documents were checked and evaluated, and the Price Quotation was announced by the Chairperson as Php 79,500.00 less than the ABC of Php 100,000.00;

WHEREAS, upon validation on the documentary requirements of La Hermosa Pit Stop Shop and General Merchandise, Incorporated, the BAC found the Technical and Financial documents as responsive;

WHEREAS, the BAC declared the Price Quotation of La Hermosa Pit Stop Shop and General Merchandise, Incorporated as the Single Calculated and Responsive Quotation for the One (1) Lot-Supply of Labor and Materials for the Minor Repair and Maintenance Services of Motor Vehicles of PPA, PMO-Zamboanga for CY2018;

NOW, THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby, RESOLVE, as it is hereby RESOLVED:

- 1) To endorse La Hermosa Pit Stop Shop and General Merchandise, Incorporated as the Supplier with the Single Calculated and Responsive Quotation for the One (1) Lot-Supply of Labor and Materials for the Minor Repair and Maintenance Services of Motor Vehicles of PPA, PMO-Zamboanga for CY2018 in amount of Php 79,500.00; and
- 2) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.




