BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. SH- 13 - 2018

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 52.1 (b) - Shopping posted the Request for Quotation (RFQ) for the "One (1) Lot – Supply and Delivery of three (3) units Smart Television Set, 55-inch, 4K Ultra HD, Android TV, Wifi Direct Screen with 4 HDMI Input" of PPA, PMO-Zamboanga with an Approved Budget for the Contract (ABC) of Php 180,000.00 from May 30-June 13, 2018, in the PPA Website, PhilGEPS Website, and PPA-PMO Bulletin Boards;

WHEREAS, RFQs were sent to five (5) suppliers, namely: 1) Z.C. LM Enterprises; 2) Phone Patch Marketing; 3) RCL Marketing; 4) Emcor-Veterans; and 5) Emcor-Nuñez;

WHEREAS, three (3) suppliers submitted their Price Quotation Envelopes before the deadline, namely: 1) Z.C. LM Enterprises; 2) Phone Patch Marketings; and 3) RCL Marketing before the deadline;

WHEREAS, the BAC opened the envelopes of the said suppliers on June 13, 2018 at 10:00 AM containing the Technical and Financial Requirements;

WHEREAS, the submitted technical and financial documents were checked and evaluated. The results were detailed below:




