**BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

**BAC RESOLUTION NO. SVP- 14 - 2018**

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement re-posted the Request for Quotation (RFQ) for the "One (1) Lot Supply of Labor and Materials for the Provision Of Various Services Such As Photocopy, Blue And White Print, Binding, Duplo, Auto Cad Printing/CAD Plotting and Tarpaulin Printing for PPA, PMO-Zamboanga" with an Approved Budget for the Contract (ABC) of Php 190,000.00 from June 13-25, 2018, in the PPA Website, PhilGEPS Website, and PPA-PMO Bulletin Boards;

WHEREAS, RFQs were sent to three (3) Suppliers, namely: 1) Copier Solutions Specialist; 2) Ceejays Enterprises; and 3) Astoria Printing and Publishing;

WHEREAS, out of the three (3) suppliers, only Copier Solutions Specialist submitted its Price Quotation Envelopes before the deadline;

WHEREAS, the BAC opened the envelopes of Copier Solutions Specialist on June 25, 2018 at 10:00 AM containing the Technical and Financial Requirements;

WHEREAS, the submitted technical documents were checked and found compliant, and rated as "Passed". The financial documents were checked and evaluated, and the Price Quotation was announced by the Chairperson as Php 173,484.00 less than the ABC of Php 190,000.00;

WHEREAS, upon evaluation on the documentary requirements of Copier Solutions Specialist, the BAC found the Technical and Financial documents as responsive;

WHEREAS, the BAC declared the Price Quotation of Copier Solutions Specialist as the bidder with Single Calculated and Responsive Quotation for the One (1) Lot Supply of Labor and Materials for the Provision Of Various Services Such As Photocopy, Blue And White Print, Binding, Duplo, Auto Cad Printing/CAD Plotting and Tarpaulin Printing for PPA, PMO-Zamboanga;

NOW, THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby, RESOLVE, as it is hereby RESOLVED:

- 1) To endorse Copier Solutions Specialist as the Supplier with the Single Calculated and Responsive Quotation for the One (1) Lot Supply of Labor and Materials for the Provision Of Various Services such as Photocopy, Blue And White Print, Binding, Duplo, Auto Cad Printing/CAD Plotting and Tarpaulin Printing for PPA, PMO-Zamboanga in the amount of Php 173,484.00; and
- 2) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.


