**ONE (1) LOT SUPPLY OF LABOR, MATERIALS AND EQUIPMENT FOR THE  
PROVISION OF MOTORPOOL PARKING SHED, LOT 7, OPEN YARD, PORT AREA,  
PORT OF ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC OF PHP991,800.00**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the ONE (1) LOT SUPPLY OF LABOR, MATERIALS AND EQUIPMENT FOR THE PROVISION OF MOTORPOOL PARKING SHED, LOT 7, OPEN YARD, PORT AREA, PORT OF ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC OF PHP991,800.00 on July 31 to August 7, 2023, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to three (3) suppliers, namely: 1.) AJ Construction and Trading, 2.) Majda Construction and Development; 3.) 3A's Construction Supply, out of the three (3) only two (2) submitted their price quotation;

WHEREAS, the BAC opened the sealed price quotation of supplier on August 9, 2023, at 10:00AM. The results were as follows:

To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


