AND FENCE, PORT OF ZAMBOANGA, ZAMBOANGA CITY**

***BAC Resolution Declaring Single Calculated and Responsive Bid (SCRB)
and Recommending Approval***

BAC RESOLUTION NO. ZAM-PGEPCS-03-2018

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid and Bidding Documents for the Repair of Drainage System (along Perimeter Fence Market Side) and Fence, Port of Zamboanga, Zamboanga City on July 16, 2018 up to the submission of bids on August 06, 2018 in the PPA Website, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards and in the Philippine Star on July 16, 2018, a newspaper of general circulation;

WHEREAS, in response to the said advertisements, five (5) prospective bidders signified their intention to bid and purchased the bidding documents, namely: 1. JC Dela Vega Construction Supply; 2. YLL Construction and Supply; 3. RR&B Finest Construction and Development Corporation; 4. Stoneline Construction; and 5. ZET Construction;

WHEREAS, the BAC conducted a **Pre-Bid Conference** on **July 23, 2018** discussing among others the eligibility, technical and financial requirements of the project to be bid pursuant to Section 22 of the RA 9184;

WHEREAS, in the **receipt and opening of bids** on **August 06, 2018, 10:00 AM** four (4) prospective bidders submitted their bid envelopes before the deadline; namely: 1. JC Dela Vega Construction Supply; 2. RR&B Finest Construction and Development Corporation; 3. Stoneline Construction; and 4. ZET Construction;

WHEREAS, the BAC opened first the submitted envelope of JC Dela Vega Construction Supply. It was found out that it contained a letter of non-participation which informed the body that their estimated bid price exceeded the required ABC;

WHEREAS, the BAC opened the submitted envelope of the next bidder, ZET Construction. It was found out that it also contained a letter of non-participation which informed the body that their estimated bid price exceeded the required ABC;

WHEREAS, the BAC opened the **Technical Envelope** of the next bidder, RR&B Finest Construction and Development Corporation and checked each item of the technical documents against a checklist using a non-discretionary "pass/fail" criterion. The BAC found out that the technical documents were compliant per requirements prescribed in **ITB Clause 12. Documents Comprising the Bid: Eligibility and Technical Components** and rated as "PASSED";

WHEREAS, the BAC proceeded to open the Second Envelope of RR&B Finest Construction and Development Corporation and checked its financial documents against the requirements prescribed in **ITB Clause 13. Documents Comprising the Bid: Financial Component**, the Chairperson announced that the submitted financial documents were compliant and the bid amount **as read was Php18, 982,179.70** lesser than the ABC. The BAC rated the financial bid as "PASSED";

WHEREAS, the BAC opened the **Technical Envelope** of next bidder, Stoneline Construction and checked each item of the technical documents against a checklist using a non-discretionary "pass/fail" criterion, the BAC found out that the technical documents were not

compliant per requirements prescribed in **ITB Clause 12. Documents Comprising the Bid: Eligibility and Technical Components** and rated as "FAILED". The financial envelope was returned unopened;

WHEREAS, the BAC conducted the detailed evaluation of Bid, after RR&B Finest Construction and Development Corporation passed the technical and financial bids pursuant to **ITB Clause 24. Opening and Preliminary Examination of Bids**, to determine the Single Calculated Bid;

WHEREAS, in the bid evaluation, the BAC determined the calculated bid price of RR&B Finest Construction and Development Corporation at **Php18,982,179.70**;

WHEREAS, after the bid has been received, opened, examined, and evaluated, the BAC declared the **BID OF RR&B FINEST CONSTRUCTION AND DEVELOPMENT CORPORATION AS THE SINGLE CALCULATED BID in the amount of Php18,982,179.70**;

WHEREAS, upon post-qualification conducted on August 9 to 10, 2018 on the submitted eligibility, technical and financial documents of **RR&B Finest Construction and Development Corporation**, the result of Post-Qualification was **RESPONSIVE**;

NOW THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To endorse the bid of **RR&B Finest Construction and Development Corporation** as the **SINGLE CALCULATED AND RESPONSIVE BID** for the **Repair of Drainage System (along Perimeter Fence Market Side) and Fence, Port of Zamboanga, Zamboanga City** in the Amount of **Php18,982,179.70**.
- b) To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.
