**ONE (1) LOT SUPPLY OF LABOR AND MATERIALS FOR THE FABRICATION OF TWO (2) UNITS WOODEN CABINET, MADE OF HARD WOOD FOR ENGINEERING SERVICES DIVISION, PPA, PMO-ZAMBOANGA**

**BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

**BAC RESOLUTION NO. SVP- 26 - 2018**

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation (RFQ) for the "One (1) Lot Supply of Labor and Materials for the Fabrication of Two (2) units Wooden Cabinet, made of hard wood for Engineering Division, PPA, PMO-Zamboanga" with an Approved Budget for the Contract (ABC) of Php 80,000.00 from October 15-23, 2018, in the PPA Website, PhilGEPS Website, and PPA-PMO Bulletin Boards;

WHEREAS, RFQs were sent to three (3) Suppliers, namely: 1) Curuan Home Furnishing; 2) RM Furnitures Shop; and 3) ZC Filipinas Furniture;

WHEREAS, out of the three (3) suppliers, only ZC Filipinas Furniture submitted its Price Quotation Envelope together with the Eligibility Compliance Certificate before the deadline. The Eligibility Compliance was issued by the Administrative Division Manager of PPA, PMO-Zamboanga which certified that ZC Filipinas Furniture had already complied with requirement for eligibility documents;

WHEREAS, the BAC opened the envelope of ZC Filipinas Furniture on October 24, 2018 at 10:00 AM containing the financial requirement;

WHEREAS, the financial documents were checked and evaluated, and the Price Quotation was announced by the Chairperson as Php 80,000.00 equal to the ABC of Php 80,000.00;

WHEREAS, upon evaluation on the documentary requirements of ZC Filipinas Furniture, the BAC found the Technical and Financial documents as responsive;

WHEREAS, the BAC declared the Price Quotation of ZC Filipinas Furniture as the bidder with Single Calculated and Responsive Quotation for the One (1) Lot Supply of Labor and Materials for the Fabrication of Two (2) units Wooden Cabinet, made of hard wood for Engineering Division, PPA, PMO-Zamboanga;

NOW, THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby, RESOLVE, as it is hereby RESOLVED:


- 1) To endorse ZC Filipinas Furniture as the Supplier with the Single Calculated and Responsive Quotation for the One (1) Lot Supply of Labor and Materials for the Fabrication of Two (2) units Wooden Cabinet, made of hard wood for Engineering Division, PPA, PMO-Zamboanga in the amount of Php 80,000.00; and
- 2) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.




