



BAC RESOLUTION DECLARING FAILURE OF BIDDING AND RECOMMENDING APPROVAL

ONE (1) LOT SUPPLY OF MANPOWER, TOOL/EQUIPMENT AND PROVISION OF BASIC AND SPECIALIZED PPE FOR THE COLLECTION, TRANSPORTATION AND TREATMENT OF HAZARDOUS WASTE OF PMO ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC of ₱350,622.90.

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the **ONE (1) LOT SUPPLY OF MANPOWER, TOOL/EQUIPMENT AND PROVISION OF BASIC AND SPECIALIZED PPE FOR THE COLLECTION, TRANSPORTATION AND TREATMENT OF HAZARDOUS WASTE OF PMO ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC of ₱350,622.90** on November 25 to December 02, 2024 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to three (3) suppliers, namely: RMS Petroleum on November 25, 2024, ARC Merchandising on November 25, 2024 and Vertex Maritime International Trading on November 25, 2024.

WHEREAS, in response to the advertisement, none of the three (3) suppliers submitted a price quotation before the published submission deadline on December 02, 2024 at 2:00 P.M.

NOW THEREFORE, We, the Members of the PMO Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

To declare the procurement of **ONE (1) LOT SUPPLY OF MANPOWER, TOOL/EQUIPMENT AND PROVISION OF BASIC AND SPECIALIZED PPE FOR THE COLLECTION, TRANSPORTATION AND TREATMENT OF HAZARDOUS WASTE OF PMO ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC of ₱350,622.90** as Failure of Bidding since there were no bids received and will be subject for review and reposting.
