

BAC RESOLUTION FOR ONE (1) CONSULTANCY PROJECT DECLARING SINGLE CALCULATED AND RESPONSIVE BIDDER AND RECOMMENDING APPROVAL BAC-EP-ZDN-No. 2018-013

WHEREAS, PMO Zamboanga del Norte (ZDN) is seeking to procure thru Consultancy Project for the Supply of Labor, Tools, Materials and Equipment for the ECC Application for the Proposed Extension of RC Pier and All Other Future Infrastructure Projects, Port of Sindangan, Sindangan, ZDN with an ABC of Php593,810.00;

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga del Norte advertised/posted the Invitation to Bid for the above-mentioned project in the Phil-GEPS, PPA Website, and in a conspicuous place at the premises of the PPA, PMO-ZDN, Port of Dapitan, Dapitan City continuously on July 11, 2018 until on the schedule of opening of bids on December 4, 2018 at 10:00 in the morning;

WHEREAS, the bid price of Alterra Geomatics & Construction amounting to Php593,000.00 for the Supply of Labor, Tools, Materials and Equipment for the ECC Application for the Proposed Extension of RC Pier and All Other Future Infrastructure Projects, Port of Sindangan, Sindangan, ZDN was found to be as the Single Calculated Bids;
