**"A RESOLUTION DECLARING KHAN KON CHI CONSTRUCTION  
AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE  
PROJECT PROPOSED REPAIR AND IMPROVEMENT OF MAKAR WHARF MAIN  
AND NORTH GATE, MAKAR WHARF PORT OF GENERAL SANTOS"**

**WHEREAS**, THE Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project Proposed Repair and Improvement of Makar Wharf Main and North Gate, Makar Wharf, Port of General Santos with an Approved Budget for the Contract (ABC) of **Twelve Million Nine Hundred Ninety Two Thousand Four Hundred Fifty Three Pesos (Php12,992,453.00)** only;

**WHEREAS**, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board;

**WHEREAS**, the said Invitation to Bid was also published in the Philippine Star;

**WHEREAS**, in response to the said publication and posting requirement, only one (1) bidder procured the bidding documents namely Khan Kon Chi Construction;

**WHEREAS**, the said bidder successfully dropped its bid on time;

**WHEREAS**, a corresponding post qualification was conducted by the Technical Working Group (TWG) of the BAC-EP on December 14 to December 15, 2015;

**WHEREAS**, the TWG, during the December 17, 2015 meeting of the BAC-EP, reported its validation and confirmation of the legal, technical and financial requirements submitted by Khan Kon Chi Construction;


**NOW, THEREFORE**, We the members of the Bids and Awards Committee, hereby **RESOLVED** as it is **RESOLVED**:

- a) To declare Khan Kon Chi Construction as the Single Calculated and Responsive Bidder for the project Proposed Repair and Improvement of Makar Wharf Main and North Gate, Makar Wharf, Port of General Santos with the bid amount of **Twelve Million Nine Hundred Sixty One Thousand Three Hundred Seventy Two and 16/100 Pesos (Php12,961,372.16)** inclusive of 12% VAT

- b) To recommend to the Head of the Procuring Entity for the approval of the said findings and issuance of the Notice of Award.
