**"A RESOLUTION DECLARING MRBII CONSTRUCTION CORPORATION
AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT
REPAIR OF DAMAGED CONCRETE PAVEMENT AT CY1 AND INFRONT OF TRANSIT
SHED NOS. 1, 2 & 3 INCLUDING DRAINAGE SYSTEM, PORT OF GENERAL SANTOS,
MAKAR WHARF, GENERAL SANTOS CITY"**

WHEREAS, THE Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project Repair of Damaged Concrete Pavement at CY1 and Infront of Transit Shed Nos. 1, 2 and 3 Including Drainage System, Port of General Santos, Makar Wharf, General Santos City with an Approved Budget for the Contract (ABC) of **Sixteen Million Eight Hundred Sixty Eight Thousand Seven Hundred Twenty Four Pesos (Php16,868,724.00)** only;

WHEREAS, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board;

WHEREAS, the said Invitation to Bid was also published in the Philippine Star;

WHEREAS, in response to the said publication and posting requirement, five (5) bidders procured the bidding documents namely Khan Kon Chi Construction, Teddie Construction Development, Inc., Marbel Construction Development, Zet Construction and MRBII Construction Corp.;

WHEREAS, two (2) bidders successfully dropped its bid on time;

WHEREAS, IN Resolution No. 23 Series of 2015 dated November 27, 2015, the BAC-EP declared MRBII Construction Corp as Single Calculated Bidder;

WHEREAS, a corresponding post qualification was conducted by the Technical Working Group (TWG) of the BAC-EP on December 7 to December 8, 2015;

WHEREAS, the TWG, during the December 9, 2015 meeting of the BAC-EP, reported its validation and confirmation of the legal, technical and financial requirements submitted by MRBII Construction Corp;


NOW, THEREFORE, We the members of the Bids and Awards Committee, hereby **RESOLVED** as it is **RESOLVED**:


- a) To declare MRBII Construction Corp as the Single Calculated and Responsive Bidder for the project Repair of Damaged Concrete Pavement at CY1 and Infront of Transit Shed Nos. 1, 2 and 3 Including Drainage System, Port of General Santos, Makar Wharf, General Santos City with the bid amount of **Sixteen Two Million Eight Hundred Four Thousand One Hundred Twelve and 87/100 Pesos (Php 16,804,112.87) Exclusive of 12% VAT;**
- b) To recommend to the Head of the Procuring Entity for the approval of the said findings and issuance of the Notice of Award.
