

  6. Tax Clearance Certificate issued by BIR

3. In consideration of the payments to be made by the PPA to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the PPA to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
  4. The PPA hereby covenants to pay the Consultant in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price of such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
  5. The Consultant shall complete the works in accordance with the Price Quotation Documents within Ninety (90) Calendar Days.
  6. Should the Consultant refuse or fails to satisfactorily complete the works within the specified completion period inclusive of granted time extension, if any, the Consultant shall be liable for damages for the delay and shall pay the PPA Liquidated Damages in accordance with Annex "E" Section 8 of the Revised Implementing Rules and Regulations of R.A. 9184.




