
5. Latest Income Tax and Business Tax Returns filed and Taxes paid through BIR Electronics Filing and Payments System (EFPS)

Should the Consultant refuse or fails to satisfactorily complete the works within the specified completion period inclusive of granted time extension, if any, the Consultant shall be liable for damages for the delay and shall pay the PPA Liquidated Damages in accordance with Annex "E" Section 8 of the Revised Implementing Rules and Regulations of R.A. 9184.




