This Contract made and entered into this 21st day of January 2015, in the City of General Santos, Philippines, by and between:

**PHILIPPINE PORTS AUTHORITY**, a government corporation created under Presidential Decree No. 857, as amended, with principal office at Bonifacio Drive, South Harbor, Port Area, Manila, represented by its duly authorized Port Manager of the Port Management Office (PMO) for SOCSARGEN at Makar Wharf, General Santos City, **LUIS A. CUISON**, and hereinafter referred to as **PPA**;

- And -

**KHAN KON CHI CONSTRUCTION**, a single proprietorship, with business and postal address at No. 6, Sama APMT. 2, Insular Village, Lanang, Davao City, Davao del Sur, represented herein by its owner, **ARSENIO B. GROSPE**, and hereinafter referred to as **CONTRACTOR**.

WITNESSETH:

**WHEREAS**, in accordance with Republic Act No. 9184 and its Revised Implementing Rules and Regulations (IRR), the Bids and Awards Committee for Engineering Projects (BAC-EP) posted at the PPA website, GEPS and at the PPA, PMO-SOCSARGEN bulletin board, an Invitation to Bid on November 12-18, 2014 for the project Repair of Damaged Settled Concrete Pavement at Access Road Between CYs 2 & 3, Port of General Santos;

**WHEREAS**, during the opening of bids on December 4, 2014, no bidder participated, thus, the declaration of the BAC-EP of failure of bidding;


