SANTIAGO, duly authorized for this purpose under Board Resolution No. 2466, as contained in Secretary's Certificate dated 02 November 2015, copy of which is hereto attached as Annex A.

and

GRUN TECH SOLUTIONS INC., herein referred to as SUPPLIER and/or WINNING BIDDER, duly organized and existing under Philippine laws, with principal office address at LG-17 Cityland 8 Condo., 98 Sen. Gil Puyat Ave., Pio Del Pilar, Makati City, represented herein by its Authorized Representative, REYNALDO N. GATMAITAN, duly authorized for this purpose, as shown in Secretary's Certificate dated 14 December 2024, copy of which is hereto attached as Annex B.

WHEREAS, the Entity invited Bids for certain goods and services, particularly the Supply, Delivery & Installation of Materials, Furniture & Fixtures for the Renovation of Treasury Department, with an approved Budget for the Contract (ABC) of Php 5,556,360.66 and has accepted a Bid by GRUN TECH SOLUTIONS INC. for those goods and services in the sum of FIVE MILLION FIVE HUNDRED FIFTY SIX THOUSAND SIX HUNDRED TWENTY NINE PESOS (Php 5,556,629.00);.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.

In consideration of the sum of FIVE MILLION FIVE HUNDRED FIFTY SIX THOUSAND SIX HUNDRED TWENTY NINE PESOS (Php 5,556,629.00) or such other sums as may be ascertained, GRUN TECH SOLUTIONS INC. agrees to the Supply, Delivery & Installation of Materials, Furniture & Fixtures for the Renovation of Treasury Department, in accordance with its Bid.
- 4. The Philippine Ports Authority agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. In execution of its Works, GRUN TECH SOLUTIONS INC. shall likewise hold PPA free and harmless from any liability due to actions, damages, or accident it may cause in the course thereof.
- 6. The failure of PPA to insist upon a strict performance of any of the terms, conditions and covenants hereof shall not be deemed a relinquishment or waiver of any of the rights or remedies that it may have, nor shall it be construed as a waiver of any subsequent breach or default of its terms, conditions and covenants which shall continue to be in full force and effect. Silence on the part of PPA shall not be considered as condonation or waiver of any breach or default by GRUN TECH SOLUTIONS INC. of any covenant or condition herein provided. No waiver by PPA of its rights under this Contract shall be deemed to have been made unless expressly made in writing and signed by its duly authorized representative.
