FOR THE PROCUREMENT OF GENERAL SUPPORT SERVICES FOR PPA PORT
MANAGEMENT OFFICES (PMOs) – VISAYAS CLUSTER

This Contract made and entered into this _____ day of **JAN 15 2020** 2020, in Manila, Philippines, by and between:

PHILIPPINE PORTS AUTHORITY (PPA), a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area Manila, represented herein by its General Manager, **JAY DANIEL R. SANTIAGO**, duly authorized for this purpose under Board Resolution No. 2466, Series of 2015 as contained in Secretary's Certificate dated 02 November 2015, a copy of which is attached as **Annex A**.

LSERV CORPORATION, a corporation duly organized and existing under Philippine laws with principal office address at Units C & D, 21st Floor, Petron Mega Plaza Bldg., Sen. Gil Puyat Ave., Makati City, represented in this act by its Chief Operating Officer, **JOSEPH V. ANGELES**, as evidenced by Secretary's Certificate dated 22 November 2019, a copy of which is hereto attached and made an integral part hereof as **Annex B**, and hereinafter referred to as "SERVICE PROVIDER".

ANTECEDENTS:

WHEREAS, in accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board, an Invitation to Bid for the Procurement of General Support Services for PPA Management Offices (PMOs)- Visayas Cluster, with an Approved Budget for the Contract (ABC) of Php **23,729,227.85**;

WHEREAS, in response to the said advertisement, only one (1) bidder submitted its bid for the foregoing project;

WHEREAS, after the opening of bids on 04 December 2019 and the conduct of bid evaluation and post-qualification, the bid submitted by the SERVICE PROVIDER at its unit and lump sum prices set forth in its proposal was found to be the Single Calculated Responsive Bid in the amount of **TWENTY THREE MILLION FIVE HUNDRED EIGHTY THREE THOUSAND AND 48/100 PESOS (Php 23,583,000.48)**, Philippine Currency;

WHEREAS, pursuant to Head Office BAC Resolution No. 157-2019 Series of 2019, award of contract was made to the SERVICE PROVIDER in a Notice of Award dated 19 December 2019, in the amount of **TWENTY THREE MILLION FIVE HUNDRED EIGHTY THREE THOUSAND AND 48/100 PESOS (Php 23,583,000.48)**, after submission of the required documents within the prescribed period and compliance to the conditions stipulated in the IRR;
