WHEREAS, after the opening of bids on 04 December 2019 and the conduct of bid evaluation and post-qualification, the bid submitted by the SERVICE PROVIDER at its unit and lump sum prices set forth in its proposal was found to be the Single Calculated Responsive Bid in the amount of TWENTY THREE MILLION FIVE HUNDRED EIGHTY THREE THOUSAND AND 48/100 PESOS (Php 23,583,000.48), Philippine Currency;

WHEREAS, pursuant to Head Office BAC Resolution No. 157-2019 Series of 2019, award of contract was made to the SERVICE PROVIDER in a Notice of Award dated 19 December 2019, in the amount of TWENTY THREE MILLION FIVE HUNDRED EIGHTY THREE THOUSAND AND 48/100 PESOS (Php 23,583,000.48), after submission of the required documents within the prescribed period and compliance to the conditions stipulated in the IRR;
