CONTRACT
FOR THE PROCUREMENT OF FIREARMS FOR PORT POLICE

This Contract made and entered into this JAN 16 day of 2020 2020, in Manila, Philippines, by and between:

PHILIPPINE PORTS AUTHORITY (PPA), a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area Manila, represented herein by its General Manager, **JAY DANIEL R. SANTIAGO**, duly authorized for this purpose under Board Resolution No. 2466, Series of 2015 as contained in Secretary's Certificate dated 02 November 2015, a copy of which is attached as **Annex A**.

TRUST TRADE, a corporation duly organized and existing under Philippine laws with principal office address at Unit 1106 Galleria Corporate Center, Edsa cor. Ortigas Ave., Ortigas Center, Quezon City, represented herein by its Authorized Representative, **JOSELYN GUTIERREZ-JOSE**, duly authorized for this purpose as shown in Secretary's Certificate dated 08 May 2019, a copy of which is attached as **Annex B**.

ANTECEDENTS:

In accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board, an Invitation to Bid for the Procurement of Firearms for Port Police, with an Approved Budget for the Contract (ABC) of **Php 42,880,000.00**;

In response to the said advertisement, two (2) bidders submitted their respective bids for the foregoing project;


After the opening of bids on 21 November 2019 and the conduct of bid evaluation and post-qualification, the bid submitted by TRUST TRADE at its unit and lump sum prices set forth in its proposal was found to be the Single Calculated Responsive Bid in the amount of **THIRTY FOUR MILLION SIX HUNDRED TWENTY EIGHT THOUSAND THREE HUNDRED THIRTY PESOS (Php 34,628,330.00)**, Philippine Currency;

Pursuant to Head Office BAC Resolution No. 150-2019 Series of 2019, award of contract was made to TRUST TRADE in a Notice of Award dated 04 December 2019, in the amount of **THIRTY FOUR MILLION SIX HUNDRED TWENTY EIGHT THOUSAND THREE HUNDRED THIRTY PESOS (Php 34,628,330.00)**, after submission of the required documents within the prescribed period and compliance to the conditions stipulated in the IRR;

4. In consideration of the supply and delivery of the goods and remedying any defects therein, PPA, commits pay the contract price in accordance with the Terms of Reference in conformity with the provisions of this Contract and Contract Documents.
5. This Contract shall become effective after the same shall have been signed by the Parties hereof.


