**CONTRACT AGREEMENT  
FOR THE SUPPLY AND DELIVERY OF UTILITY JACKETS**

This Contract made and entered into this \_\_\_\_\_ day of JAN 29 2021 in Manila, Philippines, by and between:

**PHILIPPINE PORTS AUTHORITY (PPA)**, herein referred to as ENTITY, is a government instrumentality created under Presidential Decree No. 857, as amended, with principal office address at PPA Bldg., Bonifacio Drive, South Harbor, Port Area, Manila, represented by **JAY DANIEL R. SANTIAGO**, duly authorized for this purpose under Board Resolution No. 2466, as contained in Secretary's Certificate dated 02 November 2015, copy of which is hereto attached as **Annex A**.

and

**DANTE'S EXECUTIVE MENSWEAR & BAG'S ACCESSORIES**, duly organized and existing under the Philippine laws, with principal office address at 1106 Lapu-Lapu St., Baclaran, Paranaque City, represented herein by its Proprietor, **ZOILO G. DIAZ**, duly registered with the Department of Trade and Industry, under Certificate of Registration No. 04316868, copy of which is hereto attached as **Annex B**.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the Supply and Delivery of Utility Jackets with an approved Budget for the Contract (ABC) of Php **10,000,000.00** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **(NINE MILLION SIX HUNDRED TEN THOUSAND FIVE HUNDRED PESOS (Php 9,610,500.00))**;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, Viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e. g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **(NINE MILLION SIX HUNDRED TEN THOUSAND FIVE HUNDRED PESOS (Php 9,610,500.00))** or such other sums as may be ascertained, **DANTE'S EXECUTIVE MENSWEAR & BAG'S ACCESSORIES** agrees for the Supply and Delivery of Utility Jackets in accordance with its Bid.
  4. The Philippine Ports Authority agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
