**PHILIPPINE PORTS AUTHORITY (PPA)**, a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area Manila, represented herein by its General Manager, **JAY DANIEL R. SANTIAGO**, duly authorized for this purpose under Board Resolution No. 2466, Series of 2015, attached herein as **Annex A**.

**DBP SERVICE CORPORATION**, a private corporation duly organized and existing in accordance with Philippine laws, with office and business address at 2nd Floor, Executive Bldg. Center, Gil Puyat Ave. corner Makati Ave., Makati City, represented in this act by its Executive Vice-President, **RAUL LUIS D. MANALIGOD**, as evidenced by Secretary's Certificate dated 28 November 2019, a copy of which is hereto attached and made an integral part hereof as Annex "B."

**ANTECEDENTS:**

WHEREAS, in accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board, an Invitation to Bid for the Procurement of General Support Services for PPA Port Management Offices (PMOs)- Luzon Cluster, with an Approved Budget for the Contract (ABC) of Php **69,867,427.30**;

WHEREAS, in response to the said advertisement, only one (1) bidder submitted its bid for the foregoing project;

WHEREAS, after the opening of bids on 04 December 2019 and the conduct of bid evaluation and post-qualification, the bid submitted by the SERVICE PROVIDER at its unit and lump sum prices set forth in its proposal was found to be the Single Calculated Responsive Bid in the amount of **SIXTY NINE MILLION SIX HUNDRED EIGHTEEN THOUSAND SEVEN HUNDRED FIFTY AND 72/100 PESOS (Php 69,618,750.72)**, Philippine Currency;

WHEREAS, pursuant to Head Office BAC Resolution No. 156-2019 Series of 2019, award of contract was made to the SERVICE PROVIDER in a Notice of Award dated 19 December 2019, in the amount of **SIXTY NINE MILLION SIX HUNDRED EIGHTEEN THOUSAND SEVEN HUNDRED FIFTY AND 72/100 PESOS (Php 69,618,750.72)**, after submission of the required documents within the prescribed period and compliance to the conditions stipulated in the IRR;

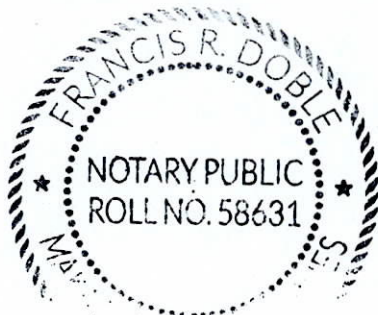
