PHILIPPINE PORTS AUTHORITY (PPA), a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area, Manila, represented herein by its General Manager, JAY DANIEL R. SANTIAGO, duly authorized for this purpose under Board Resolution No. 2445, Series of 2015, attached herein as Annex A.

- and -

E.U. JINGCO CONSTRUCTION CORPORATION/BIG J STEEL CONSTRUCTION CORPORATION/JV, duly organized and existing in accordance with Philippine laws, with principal office address at 14 Marcel Drive Ext., Brgy. Sangandaan, Quezon City, represented herein by its Authorized Managing Officer, ROGEL U. SALVADOR, duly authorized for this purpose as shown in Joint Venture Agreement dated 18 November 2021, attached herein as Annex B.

WHEREAS, the Entity is desirous that the Contractor execute the Construction of PCG-PPA K-9 Academy, Sitio Bana, Brgy. Dolores, Clark Special Economic Zone, Pampanga, with an approved Budget for the Contract (ABC) of Php 94,796,949.45 and the Entity has accepted the Bid for NINETY TWO MILLION EIGHT HUNDRED EIGHTY SIX THOUSAND NINETY TWO AND 73/100 PESOS (Php 92,886,092.73) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:
 - a. Philippine Bidding Documents (PBDs);
 - Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any

b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the sum of for NINETY TWO MILLION EIGHT HUNDRED EIGHTY SIX THOUSAND NINETY TWO AND 73/100 PESOS (Php 92,886,092.73) or such other sums as may be ascertained, E.U. JINGCO CONSTRUCTION CORPORATION/BIG J STEEL CONSTRUCTION CORPORATION/JV agrees to execute the Construction of PCG-PPA K-9 Academy, Sitio Bana, Brgy. Dolores, Clark Special Economic Zone, in accordance with its Bid.
- 4. The Philippine Ports Authority agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- In execution of its Works, E.U. JINGCO CONSTRUCTION CORPORATION/BIG J STEEL CONSTRUCTION CORPORATION/JV shall likewise hold PPA free and harmless from any liability due to actions, damages, or accident it may cause in the course thereof.
- 6. The failure of PPA to insist upon a strict performance of any of the terms, conditions and covenants hereof shall not be deemed a relinquishment or waiver of any of the rights or remedies that it may have, nor shall it be construed as a waiver of any subsequent breach or default of its terms, conditions and covenants which shall continue to be in full force and effect. Silence on the part of PPA shall not be considered as condonation or waiver of any breach or default by E.U. JINGCO CONSTRUCTION CORPORATION/BIG J STEEL CONSTRUCTION CORPORATION/JV of any covenant or condition herein provided. No waiver by PPA of its rights under this Contract shall be deemed to have been made unless expressly made in writing and signed by its duly authorized representative.
