CONTRACT AGREEMENT
FOR THE REHABILITATION/EXPANSION OF EXISTING PTB 1 & 2, PORT OF CALAPAN,
ORIENTAL MINDORO

This Contract made and entered into this _____ day of _____ 2021, in Manila, Philippines, by and between:

PHILIPPINE PORTS AUTHORITY (PPA), a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area Manila, represented herein by its General Manager, **JAY DANIEL R. SANTIAGO**, duly authorized for this purpose under Board Resolution No. 2445, Series of 2015, attached herein as **Annex A**.

D.L. CERVANTES CONSTRUCTION CORPORATION/ORIENT STAR CONSTRUCTION, INC./JOINT VENTURE, duly organized and existing in accordance with Philippine laws, with principal office address at # 13 Hercules St., Tivoli Greens Subdivision, Quezon City, represented herein by its Authorized Managing Officer, **RONALD C. MANALO**, duly authorized for this purpose as shown in Joint Venture Agreement dated 14 November 2020, attached herein as **Annex B**.

WHEREAS, the Entity is desirous that the Contractor execute the Rehabilitation/Expansion of Existing PTB 1 & 2, Port of Calapan, Oriental Mindoro with an approved Budget for the Contract (ABC) of Php **353,701,605.28** and the Entity has accepted the Bid for **THREE HUNDRED FIFTY THREE MILLION EIGHT HUNDRED FORTY EIGHT AND 44/100 (Php 353,000,848.44)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, Viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any

- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e. g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- d. Notice of Award of Contract; and the Bidder's conforme thereto; and

- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **THREE HUNDRED FIFTY THREE MILLION EIGHT HUNDRED FORTY EIGHT AND 44/100 (Php 353,000,848.44)** or such other sums as may be ascertained, **D.L. CERVANTES CONSTRUCTION CORPORATION/ORIENT STAR CONSTRUCTION, INC./** Joint Venture agrees to the Rehabilitation/ Expansion of Existing PTB 1 & 2, Port of Calapan, Oriental Mindoro in accordance with its Bid.

4. The Philippine Ports Authority agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
