This Contract made and entered into this 03 MAR 2020 2020, in Manila, Philippines, by and between:

PHILIPPINE PORTS AUTHORITY (PPA), a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area Manila, represented herein by its General Manager, **JAY DANIEL R. SANTIAGO**, duly authorized for this purpose under Board Resolution No. 2466, Series of 2015 as contained in Secretary's Certificate dated 02 November 2015, a copy of which is attached as **Annex A**.

COLUMBIA TECHNOLOGIES, INC., a private corporation duly organized and existing in accordance with Philippine laws, with office and business address at 1136-1146 J. Nakpil St., Malate II, Manila, represented in this act by its President, **JOSE M. RAMOS, JR.**, as evidenced by Secretary's Certificate dated 11 December 2019, a copy of which is hereto attached and made an integral part hereof as **Annex B**.

ANTECEDENTS:

In accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board, an Invitation to Bid for the Procurement of Information Technology (IT) Resources (*Lot 3 – 80 Column 24-Pin Dot Matrix Printers*), with an Approved Budget for the Contract (ABC) of Php 2,727,900.00;


In response to the said advertisement, only one (1) bidder submitted its bid for the foregoing project;


After the opening of bids on 19 December 2019 and the conduct of bid evaluation and post-qualification, the bid submitted by COLUMBIA TECHNOLOGIES, INC. at its unit and lump sum prices set forth in its proposal was found to be the Single Calculated Responsive Bid in the amount of **TWO MILLION FIVE HUNDRED SEVENTY NINE THOUSAND EIGHT HUNDRED FIFTY PESOS (Php 2,579,850.00)**, Philippine Currency;

Pursuant to Head Office BAC Resolution No. 009-2020 Series of 2020, award of contract was made to COLUMBIA TECHNOLOGIES, INC. in a Notice of Award dated 24 January 2020, in the amount **TWO MILLION FIVE HUNDRED SEVENTY NINE THOUSAND EIGHT HUNDRED FIFTY PESOS (Php 2,579,850.00)**, after submission of the required documents within the prescribed period and compliance to the conditions stipulated in the IRR;
