This Contract made and entered into the UN 2 3 2020 2020, in Manila, Philippines, by and between:

PHILIPPINE PORTS AUTHORITY, a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area, Manila, represented herein by its General Manager, JAY DANIEL R. SANTIAGO, authorized under Board Resolution No. 2445, series of 2015, dated 10 August 2015, attached as Annex "A," hereinafter referred to as "PPA".

IBC INTERNATIONAL BUILDERS CORPORATION, duly organized and existing in accordance with Philippine laws, with office and business address at #58 Avanceña Street, Molo, Iloilo City, represented its Authorized Representative, HELEN EDITH LEE TAN, as evidenced by Secretary's Certificate dated 05 December 2019, attached as Annex "B," hereinafter referred to as "CONTRACTOR."

ANTECEDENTS:

WHEREAS, in accordance with Republic Act (RA) No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board, an Invitation to Bid for the Alegria Port Development Project, Port of Alegria, Buruanga, Aklan, with an Approved Budget for the Contract (ABC) of **Php 217,619,862.09**;

WHEREAS, in response to the said advertisement, four (4) bidders submitted their respective bids for the foregoing project;

WHEREAS, after the opening of bids on 10 December 2019 and the conduct of bid evaluation and post-qualification, the bid submitted by the CONTRACTOR at its unit and lump sum prices set forth in its proposal was found to be the Lowest Calculated Responsive Bid in the amount of TWO HUNDRED FOURTEEN MILLION EIGHT HUNDRED FIFTY THOUSAND PESOS (Php 214,850,000.00), Philippine Currency;

WHEREAS, pursuant to Head Office BAC Resolution No. 002-2020 55...5
