CONTRACT
FOR THE PROCUREMENT FOR THE SUPPLY, DELIVERY AND ASSEMBLY OF TWENTY-TWO (22) UNITS OF MOBILE SHOWER ROOMS FOR THE PORT MANAGEMENT OFFICES

This Contract made and entered into this 13 day of JUL 2020, in PAASIC CITY, Philippines, by and between:

PHILIPPINE PORTS AUTHORITY (PPA), a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area Manila, represented herein by its General Manager, **JAY DANIEL R. SANTIAGO**, duly authorized for this purpose under Board Resolution No. 2466, Series of 2015 as contained in Secretary's Certificate dated 02 November 2015, a copy of which is attached as **Annex A**.

BT INDUSTRIES, INCORPORATED, a corporation duly organized and existing under Philippine laws, with principal office address at 118 Kanlaon St., Brgy. Lourdes, Quezon City, represented herein by its Authorized Representative, **ARIEL V. BASAS**, duly authorized for this purpose as shown in Secretary's Certificate dated 13 March 2020, a copy of which is attached as **Annex B**.

ANTECEDENTS:

In accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board, an Invitation to Bid for the Procurement for the Supply, Delivery and Assembly of Twenty-Two (22) Units of Mobile Shower Rooms for the Port Management Offices, with an Approved Budget for the Contract (ABC) of Php 15,000,000.00;

In response to the said advertisement only one (1) bidder submitted its bid for the foregoing project;

After the opening of bids on 05 June 2020 and the conduct of bid evaluation and post-qualification, the bid submitted by BT INDUSTRIES INCORPORATED at its unit and lump sum prices set forth in its proposal was found to be the Single Calculated Responsive Bid in the amount of **FOURTEEN MILLION NINE HUNDRED SIXTEEN THOUSAND PESOS (Php 14,916,000.00)**, Philippine Currency;

Pursuant to Head Office BAC Resolution No. 040-2020 Series of 2020, award of contract was made to BT INDUSTRIES INCORPORATED in a Notice of Award dated 17 June 2020, in the amount of **FOURTEEN MILLION NINE HUNDRED SIXTEEN THOUSAND PESOS (Php 14,916,000.00)**, after submission of the required documents within the prescribed period and compliance to the conditions stipulated in the IRR;
