**PHILIPPINE PORTS AUTHORITY**, a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area, Manila, represented herein by its duly authorized General Manager, **JAY DANIEL R. SANTIAGO**, and hereinafter referred to as "**PPA**";

- and -

**DIVERSIFIED INFRASTRUCTURE AND ARCHITECTURAL DEVELOPMENT WORKS CORPORATION** (TIN No. 009-788-882-000), duly organized and existing in accordance with Philippine laws, with business and postal address at 8<sup>th</sup> Floor, Richbelt Tower Condominium, Annapolis St., Brgy. Greenhills, San Juan City, represented in this act by its President, **GERALD C. BOBADILLA**, as evidenced by Secretary's Certificate dated 15 April 2019, a copy of which is hereto attached and made an integral part hereof as Annex "1", and hereinafter referred to as "**CONSULTANT**."

WHEREAS, in accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board, a Request for Expression of Interest for the Procurement of Technical Support Services for the Philippine Ports Authority's Core Application Systems);

WHEREAS, in response to the said advertisement, only one (1) bidder submitted its bid for the foregoing project;

WHEREAS, after the opening of Technical and Financial Proposals on 11 and 25 June 2019, respectively, and the conduct of bid evaluation and post-qualification, the bid submitted by the CONSULTANT at its unit and lump sum prices set forth in its proposal was found to be the Single Rated and Responsive Bid in the amount of **TWELVE MILLION NINE HUNDRED NINETY ONE THOUSAND ONE HUNDRED FORTY EIGHT AND 62/100 PESOS ( Php 12,991,148.62 )**, Philippine Currency;


WHEREAS, pursuant to Head Office BAC Resolution No. 078-2019 Series of 2019, award of contract was made to the CONSULTANT in a Notice of Award dated 19 July 2019, in the amount of **TWELVE MILLION NINE HUNDRED NINETY ONE THOUSAND ONE HUNDRED FORTY EIGHT AND 62/100 PESOS ( Php 12,991,148.62)**, after submission of the required documents within the prescribed period and compliance to the conditions stipulated in the IRR;
