**PHILIPPINE PORTS AUTHORITY (PPA)**, a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area Manila, represented herein by its General Manager, **JAY DANIEL R. SANTIAGO**, duly authorized for this purpose under Board Resolution No. 2466, Series of 2015 as contained in Secretary's Certificate dated 02 November 2015, a copy of which is attached as **Annex A**.

**TOYOTA ALABANG, INC.**, a corporation duly organized and existing under Philippine laws, with principal office address at Alabang-Zapote Road corner Filinvest Avenue, Alabang, Muntinlupa City, represented herein by its Authorized Representative, **ROBERT CEASAR J. **ANTECEDENTS:**

In accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board and sent invitation letters to three (3) suppliers, a Request for Proposal (RFP) for the Supply and Delivery of Multi-Purpose Vehicles {Under Negotiated Procurement (Two-Failed Biddings)}, with an Approved Budget for the Contract (ABC) of Php 28,340,000.00;

In response to the invitation, only one (1) bidder submitted its proposal for the foregoing project;

After the opening of the submitted proposal on 14 August 2020, the bid proposal submitted by TOYOTA ALABANG, INC. at its unit and lump sum prices set forth in its proposal was found to be the Single Calculated Responsive Bid in the amount of **TWENTY EIGHT MILLION THREE HUNDRED FORTY THOUSAND PESOS (Php 28,340,000.00)**, Philippine Currency;

Pursuant to Head Office BAC Resolution No. 061-2020 Series of 2020, award of contract was made to TOYOTA ALABANG, INC. in a Notice of Award dated 22 September 2020, in the amount of **TWENTY EIGHT MILLION THREE HUNDRED FORTY THOUSAND PESOS (Php 28,340,000.00)**, after submission of the required documents within the prescribed period and compliance to the conditions stipulated in the IRR;
