In response to the invitation, only one (1) bidder submitted its proposal for the foregoing project;

After the opening of the submitted proposal on 14 August 2020, the bid proposal submitted by TOYOTA ALABANG, INC. at its unit and lump sum prices set forth in its proposal was found to be the Single Calculated Responsive Bid in the amount of TWENTY EIGHT MILLION THREE HUNDRED FORTY THOUSAND PESOS (Php 28,340,000.00), Philippine Currency;

Pursuant to Head Office BAC Resolution No. 061-2020 Series of 2020, award of contract was made to TOYOTA ALABANG, INC. in a Notice of Award dated 22 September PESOS (Php 28,340,000.00), after submission of the required documents within the prescribed per person to the conditions stipulated in the IRR;
