CONTRACT
FOR THE PROCUREMENT OF FURNITURE & FIXTURES FOR CAGAYAN DE ORO
PASSENGER TERMINAL BUILDING

This Contract made and entered into this OCT 23 2019 day of _____ 2019, in Manila, Philippines, by and between:

PHILIPPINE PORTS AUTHORITY, a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area, Manila, represented herein by its duly authorized General Manager, **JAY DANIEL R. SANTIAGO**, and hereinafter referred to as "**PPA**";

- and -

PROGRESS HOME & OFFICE FURNISHINGS. (TIN No. 002-884-643-009), a private corporation duly organized and existing in accordance with Philippine laws, with office and business address at 73 Panay Ave., Brgy. Paligsahan, Quezon City, represented in this act by its Authorized Representative, **DELMER B. EBUEZA**, as evidenced by Secretary's Certificate dated 10 June 2019, a copy of which is hereto attached and made an integral part hereof as Annex "1", and hereinafter referred to as "**SUPPLIER**."

WITNESSETH:

WHEREAS, in accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board, an Invitation to Bid for the Procurement of Furniture & Fixtures for Cagayan de Oro Passenger Terminal Building;

WHEREAS, in response to the said advertisement, two (2) bidders submitted their respective bids for the foregoing project;

WHEREAS, after the opening of bids on 15 August 2019 and the conduct of bid evaluation and post-qualification, the bid submitted by the SUPPLIER at its unit and lump sum prices set forth in its proposal was found to be the Single Calculated Responsive Bid in the amount of **SIXTEEN MILLION NINE HUNDRED SEVENTY EIGHT THOUSAND ONE HUNDRED THIRTY TWO AND 35/100 PESOS (Php 16,978,132.35)**, Philippine Currency;

WHEREAS, pursuant to Head Office BAC Resolution No. 114-2019 Series of 2019, award of contract was made to the SUPPLIER in a Notice of Award dated 24 September 2019, in the amount of **SIXTEEN MILLION NINE HUNDRED SEVENTY EIGHT THOUSAND ONE HUNDRED THIRTY TWO AND 35/100 PESOS (Php 16,978,132.35)**, after submission of the required documents within the prescribed period and compliance to the conditions stipulated in the IRR;
