SANTIAGO, duly authorized for this purpose under Board Resolution No. 2466, Series of 2015 as contained in Secretary's Certificate dated 02 November 2015, a copy of which is attached as Annex A.

BOSTON HOME INC., a corporation duly organized and existing under Philippine laws, with principal office address at 168 Apo St., Sta. Mesa Heights, Quezon City, represented herein by its Authorized Representative, DAHLIA G. UBAY, duly authorized for this purpose as shown in Secretary's Certificate dated 01 September 2020, a copy of which is attached as Annex B.

ANTECEDENTS:

In accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board, an Invitation to Bid for the Supply and Delivery of Diaper Changers to Port Areas and Building, with an Approved Budget for the Contract (ABC) of Php 12,000,000.00;

In response to the said advertisement, only one (1) bidder submitted its bid for the foregoing project;

After the opening of bids on 15 September 2020 and the conduct of bid evaluation and post-qualification, the bid submitted by BOSTON HOME INC. at its unit and lump sum prices set forth in its proposal was found to be the Single Calculated Responsive Bid in the amount of ELEVEN MILLION NINE HUNDRED SEVENTY THOUSAND PESOS (Php 11,970,000.00), Philippine Currency;

Pursuant to Head Office BAC Resolution No. 064-2020 Series of 2020, award of contract was made to BOSTON HOME INC. in a Notice of Award dated 02 October 2020, in the amount of ELEVEN MILLION NINE HUNDRED SEVENTY THOUSAND PESOS (Php 11,970,000.00), after submission of the required documents within the prescribed period and compliance to the conditions stipulated in the IRR;

BOSTON HOME INC. duly accepted the award by signing its Conforme on the said Notice of Award;
