**NEW WASHINGTON, AKLAN**

**PHILIPPINE PORTS AUTHORITY**, a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area, Manila, represented herein by its duly authorized General Manager, **JAY DANIEL R. SANTIAGO**, and hereinafter referred to as "**PPA**";

- and -

**JARZOE BUILDERS, INC.** (TIN No. 009-484-978-000) / **DALEBO CONSTRUCTION AND GENERAL MERCHANDISE** (TIN No. 122-145-016-000) / **JOINT VENTURE**, duly organized and existing in accordance with Philippine laws, with office and business address at Cavsa St., Brgy. Amaya II, Tanza, Cavite, represented in this act by its Authorized Managing Officer, **CATRINA J. CASTRO**, as evidenced by Joint Venture Agreement dated 24 October 2019, a copy of which is hereto attached and made an integral part hereof as Annex "1", and hereinafter referred to as "**CONTRACTOR**."

**WITNESSETH:**

WHEREAS, in accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board, an Invitation to Bid for the Construction and Offshore Installation of Aids to Marine Navigation at Ports of Estancia, Iloilo; Culasi, Roxas City; and Dumaguit, New Washington, Aklan, with an Approved Budget for the Contract (ABC) of **Php 328,684,412.27**;

WHEREAS, in response to the said advertisement, two (2) bidders submitted their respective bids for the foregoing project;

WHEREAS, after the opening of bids on 29 October 2019 and the conduct of bid evaluation and post-qualification, the bid submitted by the CONTRACTOR at its unit and lump sum prices set forth in its proposal was found to be the Lowest Calculated Responsive Bid in the amount of **THREE HUNDRED TWENTY EIGHT MILLION THIRTEEN THOUSAND THREE HUNDRED FIFTY SEVEN AND 76/100 PESOS (Php 328,013,357.76)**, Philippine Currency;

WHEREAS, pursuant to Head Office BAC Resolution No. 052-2019 Series of 2019, award of contract was made to the CONTRACTOR in a Notice of Award dated 27 November 2019, in the amount of **THREE HUNDRED TWENTY EIGHT MILLION THIRTEEN THOUSAND THREE HUNDRED FIFTY SEVEN AND 76/100 PESOS (Php 328,013,357.76)**, after submission of the required documents within the prescribed period and compliance to the conditions stipulated in the IRR;
