FOR THE PROCUREMENT OF SECURITY SERVICES FOR PHILIPPINE PORTS AUTHORITY, PORT SECURITY CLUSTER-VISAYAS COMPRISING PORT MANAGEMENT OFFICES (PMOs) OF PANAY/GUIMARAS, NEGROS ORIENTAL/SIQUIJOR, BOHOL, NEGROS OCCIDENTAL/BACOLOD/BANAGO-BREDCO, EASTERN LEYTE/SAMAR AND WESTERN LEYTE/BILIRAN, AND TERMINAL MANAGEMENT OFFICES (TMOs)/PORTS UNDER THEIR RESPECTIVE JURISDICTION

PHILIPPINE PORTS AUTHORITY, a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area, Manila, represented herein by its duly authorized General Manager, **JAY DANIEL R. SANTIAGO**, and hereinafter referred to as "**PPA**";

- and -

LOCKHEED GLOBAL SECURITY AND INVESTIGATION SERVICES, INC. (TIN No. 200-340-177-000), a private corporation duly organized and existing in accordance with Philippine laws, with office and business address at 7F EU State Tower, 30 Quezon Ave., Quezon City, represented in this act by its Authorized Representative, **MARICAR P. PACIO**, as evidenced by Secretary's Certificate dated 20 August 2019, a copy of which is hereto attached and made an integral part hereof as Annex "1", and hereinafter referred to as "**SERVICE PROVIDER**."

WITNESSETH:

WHEREAS, in accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board, an Invitation to Bid for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster-Visayas Comprising Port Management Offices (PMOs) of Panay/Guimaras, Negros Oriental/Siquijor, Bohol, Negros Occidental/Bacolod/Banago-Bredco, Eastern Leyte/Samar and Western Leyte/Biliran, and Terminal Management Offices (TMOs)/ Ports Under Their Respective Jurisdiction;

WHEREAS, in response to the said advertisement, only one (1) bidder submitted its bid for the foregoing project;

WHEREAS, after the opening of bids on 29 August 2019 and the conduct of bid evaluation and post-qualification, the bid submitted by the SERVICE PROVIDER at its unit and lump sum prices set forth in its proposal was found to be the Single Calculated Responsive Bid in the amount of **ONE HUNDRED TWENTY MILLION NINETY FIVE THOUSAND FIVE HUNDRED NINETY ONE AND 28/100 PESOS (Php 120,095,591.28)**, Philippine Currency;

 - B. Technical and Financial Proposals;

 - E. Other contract documents that may be required by existing laws and PPA, such as:
