CONTRACT AGREEMENT FOR THE SUPPLY AND DELIVERY OF MOTOR VEHICLES FOR PORT MANAGEMENT OFFICES (PMOs)

This Agreement made and entered into this 2023 in Manila. Philippines, by and between:

PHILIPPINE PORTS AUTHORITY (PPA), herein referred to as ENTITY, is a government instrumentality created under Presidential Decree No. 857, as amended, with principal office address at PPA Bldg., Bonifacio Drive, South Harbor, Port Area, Manila, represented by JAY DANIEL R. SANTIAGO, duly authorized for this purpose under Board Resolution No. 2466, as contained in Secretary's Certificate dated 02 November 2015, copy of which is hereto attached as Annex A.

and

TOYOTA ALABANG, INC., herein referred to as SUPPLIER and/or WINNING BIDDER, duly organized and existing under Philippine laws, with principal office address at Alabang-Zapote Road Corner, Filinvest Avenue, Muntinlupa City, represented herein by its Authorized Representative, ROBERT CESAR J. MERIN, duly authorized for this purpose, as shown in Secretary's Certificate dated 16 November 2023, copy of which is hereto attached as Annex

WHEREAS, the Entity invited Bids for certain goods and services, particularly the Supply and Delivery of Motor Vehicles for Port Management Offices (PMOs), with an approved Budget for the Contract (ABC) of Php 76,250,000.00 and has accepted a Bid by TOYOTA ALABANG, INC. for those goods and services in the sum of SEVENTY SIX MILLION TWO HUNDRED TWO THOUSAND FIVE HUNDRED PESOS (Php 76,202,500.00);.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.

 - General and Special Conditions of Contract; and iii.
 - Supplemental or Bid Bulletins, if any iv.

- In consideration of the sum of SEVENTY SIX MILLION TWO HUNDRED TWO THOUSAND FIVE HUNDRED PESOS (Php 76,202,500.00) or such other sums as may be ascertained, TOYOTA ALABANG, INC. agrees to the Supply and Delivery of Motor Vehicles for Port Management Offices (PMOs), in accordance with its Bid.
- 4. The Philippine Ports Authority agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. In execution of its Works, **TOYOTA ALABANG, INC.** shall likewise hold PPA free and harmless from any liability due to actions, damages, or accident it may cause in the course thereof.
- 6. The failure of PPA to insist upon a strict performance of any of the terms, conditions and covenants hereof shall not be deemed a relinquishment or waiver of any of the rights or remedies that it may have, nor shall it be construed as a waiver of any subsequent breach or default of its terms, conditions and covenants which shall continue to be in full force and effect. Silence on the part of PPA shall not be considered as condonation or waiver of any breach or default by TOYOTA ALABANG, INC. of any covenant or condition herein provided. No waiver by PPA of its rights under this Contract shall be deemed to have been made unless expressly made in writing and signed by its duly authorized representative.
