THIS AGREEMENT, made this ______day of _______, 2022 between PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE – PALAWAN, with office at Quezon Street, Barangay Bagong Pag-Asa, Port Area, Puerto Princesa City, Palawan (hereinafter called the "Entity") and JULRIZ CONSTRUCTION & SUPPLY, with principal office at #63 Sea Plane Base 1, Puerto Princesa City, Palawan (hereinafter called the "Contractor"). WHEREAS, the Entity is desirous that the Contractor execute DOTr-LFP-PLW-01-

WHEREAS, the Entity is desirous that the Contractor execute DOTr-LFP-PLW-01-2020 ROXAS PORT DEVELOPMENT PROJECT, PORT OF ROXAS, ROXAS, PALAWAN (hereinafter called "the Works") and the Entity has accepted the Bid for FOURTEEN MILLION TWO HUNDRED EIGHTY-ONE THOUSAND SIX HUNDRED TWENTY-EIGHT PESOS & 77/100 (P 14,281,628.77) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz*.:

- **b.** Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- In consideration for the sum of FOURTEEN MILLION TWO HUNDRED EIGHTY-ONE THOUSAND SIX HUNDRED TWENTY-EIGHT PESOS & 77/100 (P 14,281,628.77) or such other sums as may be ascertained, JULRIZ CONSTRUCTION & SUPPLY agrees to execute the project DOTr-LFP-PLW-01-2020 ROXAS PORT DEVELOPMENT PROJECT, PORT OF ROXAS, ROXAS, PALAWAN in accordance with its Bid.
- 4. The **PHILIPPINE PORTS AUTHORITY, PMO-PALAWAN** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
