This Contract made and entered into this 04 day of JUL 2024, 2024 in Lucena City, Philippines, by and between;

ANTECEDENTS:

WHEREAS, the PPA is desirous that the Contractor execute **MAINTENANCE OF CANOPY AT PTB-1 AND PLANT BOXES, PORT OF BALANACAN, MOGPOG, MARINDUQUE**, hereinafter called "the Works" and the PPA has accepted the Bid/Price Quotation for **NINE HUNDRED EIGHTY-EIGHT THOUSAND NINE HUNDRED SEVENTY PESOS AND 04/100 ONLY (P 988,970.04)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


hereinafter mentioned, the Contractor hereby covenants with the PPA to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract.



5. The Contractor shall complete the works in accordance with the drawings and specifications within **TWENTY-THREE (23) CALENDAR DAYS**.
6. Should the Contractor refuses or fails to satisfactorily complete the works within the specified completion period inclusive of granted time extension, if any, the Contractor shall be liable for damages for the delay and shall pay the PPA Liquidated Damages in accordance with Annex "E" Section 8 of the Revised Implementing Rules and Regulations of R.A. 9184.






