## ANTECEDENTS:

WHEREAS, the PPA is desirous that the Contractor execute MAINTENANCE OF TMO BUILDING, MINOR STRUCTURES, LIGHTING SYSTEM, MOORING SYSTEM AND TERMITE CONTROL TREATMENT OF PORT FACILITIES, PORT OF STA. CRUZ, MARINDUQUE, hereinafter called "the Works" and the PPA has accepted the Bid/Price Quotation for NINE HUNDRED NINETY-ONE THOUSAND ONE HUNDRED NINETYSEVEN PESOS AND 86/100 ONLY (P 991,197.86) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

1. In this agreement, word and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract herein referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
(a) Price Quotation (Bid Proposal)
(b) Notice of Award of Contract and the Bidder's conforme thereto;
(c) Other contract documents that may be required by existing laws and/or the Entity.
3. PCAB License
4. Current Mayor's Permit
5. Certificate Phil-Geps Registration
6. Latest Income and Business Tax Returns
7. Omnibus Sworn Statement
8. In consideration of the payments to be made by the PPA to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the PPA to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract.
9. The PPA hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
10. The Contractor shall complete the works in accordance with the drawings and specifications within FIFTY (50) CALENDAR DAYS.
11. Should the Contractor refuses or fails to satisfactorily complete the works within the specified completion period inclusive of granted time extension, if any, the Contractor shall be liable for damages for the delay and shall pay the PPA Liquidated Damages in accordance with Annex "E" Section 8 of the Revised Implementing Rules and Regulations of R.A. 9184.
