- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of One Million Eight Hundred Ninety-nine Thousand One Hundred Thirty-Four Pesos and 95/100 (P 1,899,134.95) or such other sums as may be ascertained, RRL BUILDERS CORPORATION agrees to execute and complete the Works and remedy any defects therein in accordance with his/her/its Bid.



4. The **PHILIPPINE PORTS AUTHORITY** (*PPA*) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
