



## CONTRACT AGREEMENT

### “SUPPLY AND DELIVERY OF FRESHWATER FOR BASEPORT-ICPC, ILOILO FASTCRAFT TERMINAL, FORT SAN PEDRO AND PORT OF DUMANGAS FOR CY 2019”

THIS AGREEMENT entered into by and between:

PHILIPPINE PORTS AUTHORITY (PPA), with local office at Barangay Loboc, La Paz, Iloilo City, Philippines, represented herein by its Acting Port Manager, **EDUARDO P. GOLES** hereinafter referred to as Procuring Entity

- and -

**HUC MERCHANDISING**, with business and office address at Sta. Isabel St., Brgy. Libertad-Sta Isabel, Jaro Iloilo City represented herein by the Owner, **ALEJANDRO U. CHUA** hereinafter referred to as the Supplier:

WHEREAS, the Procuring Entity invited Bids for the “**SUPPLY AND DELIVERY OF FRESHWATER FOR BASEPORT-ICPC, ILOILO FASTCRAFT TERMINAL, FORT SAN PEDRO AND PORT OF DUMANGAS FOR CY 2019**” and has accepted a Bid by the Supplier for the supply of those goods in the sum of **THREE MILLION TWO HUNDRED NINETY TWO THOUSAND TWENTY PESOS ONLY (Php3,292,020.00)** hereinafter called “the Contract Price”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1) In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2) The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a) Bid Form and the Price Schedule submitted by the Bidder;
  - b) the Schedule of Requirements;
  - c) the Technical Specifications;
  - d) the General Conditions of Contract;
  - e) the Special Conditions of Contract; and
  - f) the Procuring Entity’s Notification of Award.
- 3) In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4) The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


